

## PRIVACY STATEMENT

### **SKV**

The privacy statement applies to the processing of personal data by the Foundation for Quality Guarantee of the Veal Sector, Chamber of Commerce number 41156588, hereinafter referred to as SKV. The protection of personal data is very important to SKV. SKV respects your privacy and will ensure that your personal data is always treated confidentially and in accordance with applicable privacy legislation.

### **What data does SKV process?**

SKV processes personal data in the context of participation in the Vitaal Kalf quality scheme, the SKV Regulations, participation in other quality schemes and the registration of veterinary medicinal products in the register as referred to in Article 1.27 of the Animal Keepers Decree and Article 5.8 of the Veterinarians Decree.

Below is an overview of the personal data we process:

- name and address details, email address and telephone number;
- UBN or UDN;
- data resulting from participation in the quality schemes mentioned above and the registration of veterinary medicinal products mentioned above;
- Other personal data that you actively provide to us.

SKV does not process special personal data.

### **What is the legal basis and purpose for data processing by SKV?**

SKV only processes personal data based on:

1. your consent;
2. the execution of the agreement concluded with you;
3. complying with legal obligations, and/or
4. the representation of SKV or a third party's legitimate interests, in the context of normal business operations and sending newsletters.

SKV processes your personal data for one or more of the following purposes:

1. to execute the agreement(s) concluded with you;
2. to conduct administration, as well as other internal management activities;
3. to be able to contact you and respond to questions you have asked;
4. to register veterinary medicinal products in the designated register within the meaning of Article 1.27 of the Animal Keepers Decree;
5. to register data in the context of participation in the quality scheme Vitaal Kalf, SKV's quality system and participation in other quality systems;
6. to handle your requests for information;
7. to be able to send SKV's digital newsletters;
8. to comply with legal obligations, such as the administration and retention obligation;
9. to deal with disputes, to have audits conducted by the Dutch Accreditation Council and by accountants.

If the personal data is processed based on consent, this consent can be withdrawn at any time.

**Is personal data exchanged with third parties?**

SKV manages the public register, which records which companies are certified under the Vitaal Kalf quality scheme.

SKV only provides personal data if this results from the provisions of the Vitaal Kalf quality scheme, the SKV quality scheme and/or other quality schemes, the designation as a register as referred to in Article 1.27 of the Animal Keepers Decree, for research purposes, in order to comply with a legal obligation or based on your consent. In the context of the quality schemes, data may be shared with the NVWA (Netherlands Food and Consumer Product Safety Authority). **Does automated decision-making and/or profiling take place?**

SKV does not use automated decision-making and/or profiling.

**For how long will my personal data be stored?**

SKV will retain your personal data during the term of your agreement with SKV and after its termination for a maximum of 5 years, unless there are reasons for a longer retention period or a different retention period has been contractually agreed. In the absence of an agreement, your personal data will be stored for the period that it is necessary to realise the purposes for which your data is collected.

**How is the data secured?**

SKV will take appropriate technical and organisational measures to protect personal data against loss or any form of unlawful processing. In this context, various measures have been taken, including an implemented security policy and using authentication to unlock access to personal data.

**What are your rights?**

Under the General Data Protection Regulation (GDPR) you have several rights, which SKV respects. These rights include the right to inspect the personal data processed by SKV and the right to correct data if this data is not (or no longer) correct. You may also object to certain processing of personal data because of your specific situation, if the processing is not based on your consent, the execution of a concluded agreement or compliance with legal obligations. Furthermore, under the conditions as stated in the GDPR, you may request the deletion of personal data or the limitation of their processing. Finally, you have the right to data portability. SKV will answer questions or requests in this context within one month in principle, but this period may be extended to three months in certain circumstances.

In addition to the rights mentioned above, you have the option of submitting a complaint to the Dutch Data Protection Authority. You can find the contact details of the Dutch Data Protection Authority via the website
